Dear Deputy Tully,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary questions, which were submitted to this department for response.

PQ: 20463/22

To ask the Minister for Health the total amount of funding received by disability service providers in the past five years; the funding received by each disability service provider in the past five years in tabular form; and if he will make a statement on the matter.

PQ: 20476/22

To ask the Minister for Health the structures that have been put in place to support dialogue and collaborative working with voluntary organisations including those representing section 38 and 39 providers and persons with disabilities and their families as contained within the HSE Service Plan 2021; and if he will make a statement on the matter.

HSE Response

In 2022, Disability Services has been allocated c. €2.3 billion to provide a range of services throughout the country and is spent in line with nationally agreed policy for disability services, whilst at the same time endeavouring to maximise value. Services include Residential and Respite Services, Day Services, PA and Home Support Services, and Therapeutic Supports.

The HSE works in partnership with organisations including Section 38, Section 39, Out of State and For Profit organisations to ensure the best level of service possible is provided to people with a disability, and their families, within the available resources. The majority of specialised disability provision (80%) is delivered through non-statutory sector service providers.

The HSE acknowledges the role and contribution of non-statutory agencies in the development and provision of health and personal social services and is committed to the development of effective working relationships as enacted by the Health Act 2004.

The HSE has over 1,045 Service Arrangements or Grant Aid Agreements with approximately 419 organisations providing a wide variety of disability services on behalf of the HSE. These Service Arrangements and Grant Aid Agreements are covered by a Governance Framework.

At the end of 2021, there were 15 Section 38 Organisations in receipt of approximately €1billion funded by HSE Disability Services. There were 222 Section 39 Organisations with either a Grant Aid Agreement or a Service



Arrangement with HSE Disability Services with funding provided amounting to approximately €723 million. The remaining organisations include Out of State and For Profit Organisations.

Dialogue and collaborative working with voluntary organisations

HSE Governance Framework

The HSE has established a formal and robust Governance Framework to cover funding relationships with all Non Statutory Agencies. The framework was introduced in order to implement the legislative provisions of the Health Act, 2004 and to reflect the requirements for public accountability whereby the HSE is legally obliged to account for all public expenditure on health and personal social services and to contractually underpin the grant-funding provided. All funding arrangements with non-statutory agencies are formalised by complying with this Governance Framework which has 2 different components:

- Part 1 A Service Arrangement that is signed every 1 to 3 years by both parties and sets out the legal requirements that the agency must comply with to receive funding for the provision of services.
- Part 2 A Set of 10 Schedules which must be completed and signed by the Agency and the HSE which sets
 out the detail of the service and the exact funding that the HSE is providing for the delivery of this service.
 This Set of Schedules also identifies the quality standards and best practice guidelines to be adhered to in the
 provision all services, along with process for managing complaints in relation to service provision.

The Part 2 Service Arrangement /Grant Aid agreement is completed every year for every separate service/ service arrangement with every organisation providing services funded by the HSE. The completion of same involves collaboration and dialogue between the HSE and the Service Provider and involves agreement on anticipated outcomes that the service will deliver, agreed performance management requirements and a reporting timetable regarding reports and meetings. This level of performance monitoring will depend on the type of service, the level of functions and level of funding provided to the organisation.

Stability and Sustainability Process

The HSE has established a structure and entered into a process with one Section 38 organisation that presented sustainability challenges. The purpose is to work through a process with them ensuring the transition, over the medium term, to the provision by the provider of high quality co-designed services meeting the needs, abilities and potential of services users with an intellectual disability or with mental health support needs, where these services align with agreed service delivery models, are appropriately and sustainably resourced and are supported by strong governance mechanisms.

Key stated principles of the process include amongst others;

- Partnership and a collaborative approach with open communication
- Consistent service user focus and a person centred approach focusing on outcomes and principles of the UNCRPD.
- Open communication with stakeholders; service users, families, staff, the Board, Government colleagues, the sector.
- Commitment to establishing and maintaining healthy and respectful communication.
- Commitment to openness and transparency from all parties.

Another section 39 entity is about to enter the process under similar circumstances and with similar commitments on both sides. The process will continue to build in response to emerging need.

HSE Engagement with Voluntary Organisations via the National Disability Umbrella Organisations during Covid 19 Public Health Emergency



Early in the crisis, the HSE put in place a formal structure for weekly (online) meetings between senior HSE officials and representatives from the disability sector. The purpose of these meetings was to facilitate the early identification and resolution of the key issues affecting front line service providers within the disability sector. These formal weekly meetings were augmented by almost daily contact between the senior officials in both sectors.

The HSE had several weekly telecons with a number of key stakeholders representing the interest of service users and their families as well as provider representative organisations such as Disability Federation of Ireland (125 organisations within membership or as associates in DFI) and the National Federation of Voluntary Service Providers (over 60 organisations within membership with Nat Fed) in identifying and addressing specific challenges for people with disabilities and their families during COVID-19. This included working together to identify and respond to challenges; guidance and advice development; and resolution of issues highlighted by member organisations.

Under the governance of the HSEs National Integrated Operations Hub chaired by the COO and work relating to vulnerable people, Disability Operations had a team in place with the responsibility for providing supports and capacity building training for the sector. A range of guidance material was developed to support people with disabilities, families and staff.

Additional to the above a series of "webinar" training modules to assist frontline staff during the COVID-19 emergency period was put in place.

There are also a series of specific national strategies, including New Directions, Transforming lives and Progressing Disability Services where collaboration between all agencies is driving improvement and change.

Transforming Lives

The needs of people with a disability extend well beyond health service provision, and the health service participates fully with other Government departments and services in the development of cross-sectoral strategies to maximise access to services and supports for people with disabilities.

In this context, there is a collective effort being made nationally and regionally to fundamentally reform how we deliver services for people with a disability and our commitment to uphold the UN Convention on the Rights of People with a Disability. Under the Transforming Lives policy, this has been a driving force of strong collaborative efforts over many years and where real progress has and continues to be made.

Transforming Lives is supported by a National Programme Office and is being delivered by a National Cross Sector Steering Group and Cross-Sector Working Groups. This involves key members from across the Disability Service sector including representatives from the HSE, the Department of Environment, the Department of Health, the Department of Public Expenditure and Reform, the National Disability Authority, Inclusion Ireland, the Umbrella Bodies and Parent Representatives.
