The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

## PQ Number: 59996/22

To ask the Minister for Health the number of facilities that have closed and ceased operations by name and location since the payments were awarded, of the recent TAPS payments of nearly €150 million distributed to nursing homes throughout the country to help manage the response to Covid-19; if any nursing homes voluntarily returned monies to his Department for any reason in tabular form; and if he will make a statement on the matter. -Fergus O'Dowd

Please find attached a list of HIQA registered Private/Voluntary Nursing Homes that were removed from the Chief Inspector's register since 2020.

I can confirm that there is no record of any nursing home that voluntarily returned a Temporary Assisted Payment Scheme (TAPS) payment to the HSE.
