"To ask the Minister for Health the current position in respect of the appointment of a replacement GP for the GP who has tendered their resignation in Blarney, County Cork; the action that his Department and the HSE are taking to recruit additional GPs for areas of growing population; and if he will make a statement on the matter."

Dear Deputy Burke,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

The HSE was advised of the upcoming resignation of Dr. Una O'Halloran's GMS GP position in Ashdale Centre in Blarney, Co. Cork on 28<sup>th</sup> September 2022, which will become vacant on 31<sup>st</sup> December 2022.

Cork Kerry Community Healthcare has arranged for an interim GP service for all GMS cardholders from 1<sup>st</sup> January 2023, for the duration of the recruitment campaign for a permanent GP to uptake Dr. O'Halloran's present GMS panel.

On Thursday 1<sup>st</sup> December, communication issued to Dr. O'Halloran's current panel of GMS cardholders to advise that an interim GP service has been arranged, and will be in place, effective from 1<sup>st</sup> January, under a temporary locum contract with Dr. Eamonn O'Grady at OB Medical Group, Old Fort Road, Ballincollig, Cork, P31XN96, until such time as a permanent GP is contracted to uptake the vacant GP position in Blarney.

In making arrangements for this interim GP service, Cork Kerry has taken cognisance of a number of factors including distance. Every effort was undertaken to keep the service as close to the original centre of practice as possible. The interim service has been arranged in line with the distance permissable for a change of main centre of practice per the GMS GP contract.

This interim service will remain until we conclude the GP recruitment campaign for the area.
