PQ 7237/22: To ask the Minister for Health if he will provide a breakdown of Departmental civil servants working in County Wexford and their respective Departmental section in tabular form; and a breakdown of State agency employees working in County Wexford in tabular form.

Dear Deputy Browne,

I refer to your recent parliamentary question in relation to staffing which was forwarded to the Health Services Executive (HSE) by the Department of Health for direct reply.

Firstly, I wish to point out that health services are delivered on a Hospital Group basis for acute hospital services and at Community Healthcare Organisation level for Primary Care, Mental Health, Disability and older person's services. This response to your question is based on this configuration i.e. Ireland East Hospital Group, which includes Wexford General Hospital, and Community Healthcare Area 5 covering Carlow, Kilkenny, South Tipperary, Waterford and Wexford. Other services, such as Ambulance Services are organised on a national basis and are not covered by this response.

The Deputy will be interested to note that, employment levels at the end of January 2022 show there were 150,903 personnel (*equating to 132,323 whole-time equivalents*) directly employed in the provision of Health & Social Care Services by the HSE and the various Section 38 hospitals and of which 21,836 personnel or 19,307 whole-time equivalents are employed in the areas outlined above.
