I refer to the above Parliamentary Question which has been referred by the Minister for Health to the Health Service Executive for direct response.

In late 2019, the HSE developed and set out a new blueprint for investment in community health and social care provision. This 'Enhanced Community Care (ECC) Model' defined core service areas for investment in key services in community settings, including: the roll out of 96 Community Healthcare Networks (CHNs). CHNs provide the foundation and organisation structure through which integrated care is delivered locally at the appropriate level of complexity, with GPs, HSCPs, nursing leadership and staff, empowered at a local level to drive integrated care delivery and supporting egress in the community.

In response to your query regarding the the total number of community healthcare networks in place; 87 of 96 CHNs are operational. A breakdown of the operational CHNs are included in the Table 1 below:

As part of the overall ECC programme allocation of 3,500 additional WTE's 1,760 additional WTE allocated for the establishment of the CHNs. A table summarizing the required WTE for the CHNs is included in *Table 2* below:-

- 329 Health and Social Care Professionals such as Speech and Language Therapists, Dietitians,
  Chiropodists/Podiatrists, Social Workers, Physiotherapists and Occupational Therapists
- 92 nursing staff such as Public Health Nurses and Community Registered General Nurses
- 52 management and administration roles such as Health Promotion and Improvement Officers



There is a continued focus on domestic and international recruitment campaigns to recruit at pace to recruit the remaining 378 WTE.
