Dear Deputy Ryan,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ: 33398/22

To ask the Minister for Health the details of waiting lists for a public nursing home bed in each county; and if he will make a statement on the matter.

The availability of residential care in public nursing homes is an important component of the overall community health care provision.

Please see attached Appendix 1 detailing waiting lists by CHO area and County.

The waiting lists need to be reviewed under the following contexts:

- Service Users on the bed waiting list may not have as yet gone through the Nursing Home Support • Scheme Process (NHSS) and some Service Users do request to be put on a waiting list for future planning. Therefore, it cannot be deemed as appropriate that their care needs are best met in residential care until such time as an application is made for the completion of a care needs assessment and that assessment is considered by a local placement forum under the Nursing Home Support Scheme Act 2009.
- During COVID-19 surges in outbreaks it has been necessary to close facilities to admissions on Public Health advice, this has negatively impacted on waiting lists.
- Service Users and their families may put themselves on multiple bed waiting lists across different care facilities.
- It is noted that where there are waiting lists for publically managed care facilities and that there is bed capacity, Service Users may decline a bed if it is situated in a multiple occupancy room.
- Once an applicant is deemed to require care through the NHSS they are not denied a service due to a lack of bed availability but may prefer to wait for a facility of their choice to become available.
- The HSE is undergoing a major capital building programme across its Community Nursing Facilities for the purpose of SI 293 compliance. This programme at times may result in temporary bed closures while refurbishment is taking place.

Despite these challenges, the HSE is continuing to provide a residential care service that is focused on quality and safety while also meeting the needs of the individual Service User.
