Dear Deputy Mythen,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary questions, which were submitted to this department for response.

PQ 34323/22

To ask the Minister for Health the number of respite beds currently operational by county in tabular form; and if he will make a statement on the matter.

PQ 34327/22

To ask the Minister for Health the number of respite centres that are rental accommodations; the cost of these rentals; and if he will make a statement on the matter.

HSE Response

The HSE and its funded Agencies provide respite care to children and adults with disabilities. Respite can occur in a variety of settings for various lengths of time, depending on the needs of the individual service user and their family or carer, and according to available resources. Respite is not always centre-based and can be provided in a number of ways, e.g. Centre based; In-Home; Home-to-Home; Family Support, etc. As a vital part of the continuum of services for families, respite potentially helps prevent out-of-home full-time residential placements, preserves the family unit, and supports family stability.

The HSE is very much aware of the importance of respite service provision for the families of both children and adults with disabilities and the impact the absence of respite service provision can have on other services being delivered.

Unmet Need and growing demand

The provision of residential respite services has come under increasing pressure in the past couple of years due to a number of impacting factors such as,

- an increase in the number of children and adults who are seeking access to respite as a reflection of general population increase;
- increasing levels of complexity across the sector due to better and improved health care;



• an increase in the age of people with a disability resulting in people presenting with "changing needs".

In addition, a significant number of respite beds have been utilised for long term residential placements due to the presenting complexity of the individual with a disability and also due to home circumstances, therefore, the numbers of people with disabilities in receipt of residential respite services and the corresponding number of respite nights has reduced when compared to previous activity.

A further impact to the delivery of respite has been in response to the regulation of service provision as set by the Health Information and Quality Authority regulatory and policy context. HIQA has established and set the way in which residential/respite services is provided requiring the Agencies comply with regulatory standards in order to meet regulation. Standards specify a requirement for personal and appropriate space impacting on the capacity and Statement of Purpose for a Designated Centre. This has had a direct impact on capacity where respite beds are no longer allowed within a residential setting e.g. vacated by residents who go home at weekends or for holidays, can no longer be used for respite. Implementation of the national policy on congregated settings (Time to Move on from Congregated Settings Policy) is also affecting capacity.

In 2021, while services were operational in all areas, there was reduced capacity due to the ongoing pandemic and necessary infection prevention and control requirements. Nevertheless, the number of respite overnights operated at (94,606), 10.9% ahead of the target for the year of 85,336, which is reflective of the easing of restrictions during the second half of 2021. The number of day only sessions operated at (16,306), -22.2% below the target of 20,958 for 2021. This was mainly due to necessary precautions to maintain physical distancing and to adhere to infection prevention and control, as would be the case in day service provision. A further reason for the reduced number would have been the shift toward alternative forms of respite (i.e. preference for in-home supports). In addition, Day Respite typically accommodates larger groups than overnight respite and often takes place in a day centre in the evening and on Saturdays (especially for children), therefore, the effect of covid measures and physical distancing has significantly reduced capacity, particularly where services are working to the same staffing.

2021 Developments

The need for increased respite facilities is acknowledged and the HSE continues to work with agencies to explore various ways of responding to this need. In accordance with the National Service Plan 2021, the HSE is endeavouring to provide nine additional centre-based respite services, providing some 10,400 additional respite nights along with a range of alternative respite projects including Saturday clubs, breakaway schemes, and summer schemes. Most of these are already in place and the remainder will be in place by second guarter of 2022.

2022 Developments

In accordance with the NSP 2022, the key priority areas in relation to Respite Services for people with disabilities and their families are:

- Establish three additional specialist centre-based services to provide 4,032 nights to 90 children, one to be Prader-Willi appropriate and the other two to provide high-support respite for children and young adults with complex support needs, in addition to seven further respite services which will provide 9,408 nights to 245 children and adults in a full year.
- Provide additional intensive respite support packages to children and young adults.

This is a key priority area for the HSE in relation to Respite Services for people with disabilities and their families and follows on from the significant investment in respite services in 2021.

Currently each CHO is working to implement these developments, including tendering where necessary, identifying appropriate facilities, recruiting staff and securing registration with HIQA. This work will influence the location and timeframe for the delivery of the ten additional centre-based respite services in all of the nine Community Healthcare Areas.



Respite Centres

The table in Appendix 1 provides a list of Respite Centres catering for adults and children throughout the nine CHO Areas, taken from the HIQA Register of Disability Designated Centres. It should be noted that in most respite centres, the occupancy levels as reported to HIQA represents the maximum number of children and adults that could attend the centre at any one time. However, operationally, the actual occupancy levels would generally be lower than the maximum due to the complexities of the people that would routinely be catered for. In addition, occupancy levels have been significantly impacted by the onset of the COVID-19 pandemic.

Rental Accomodation

HSE Disability Services provide a wide range of supports to those with physical, sensory, intellectual disability and/or autism whose needs cannot be met by mainstream services or at primary care level. Disability services focus on supporting and enabling people with disabilities to maximise their full potential and are delivered through a mix of HSE direct provision as well as through non-statutory section 38 and 39 service providers, and private providers. Sevices provided include residential and respite services.

The relationship, including the funding relationship, between these providers and the HSE is governed by way of a Service Arrangement (SA) or Grant Aid Agreement (GA) via the nine Community Healthcare Organisations. The HSE currently manages 1,045 SAs or GAs with a total of 419 organisations who are providing services including residential centres and respite centres.

Information regarding the total cost of accommodation which is rented is not collated nationally.

Information from the Health Information and Quality Authority (HIQA) indicates that there are 1,426 disability residential services providing residential and /or respite services to people with disabilities currently in Ireland.

The Registered Providers who are responsible for the management and running of these centres are either HSE or the non-statutory and private providers. Residential services are provided according to the needs and requirements of the individuals through a range of housing types from congregated settings to individual supports to people who may live semi-independently. The most common arrangement is a community group home for between 2-9 people with an intellectual disability.

It should be noted, that people accessing residential services are not a homogenous group but have hugely differing and changing needs. The model of residential/respite accommodation services has already changed significantly over the years from caring for clients in large institutional settings predominately operated by religious orders to today's model, which seeks to support individuals in a person centred way in community settings.

Housing in many cases is specially adapted to support individuals as necessary. The regulation of disability residential centres by the Regulator, HIQA, which commenced in 2013, has had a significant impact on the residential sector. Many providers have undertaken significant remedial works to their residential centres in order to achieve compliance with the regulations. Particular issues have arisen in relation to fire safety, privacy and dignity and accessibility. The HSE has invested over €68 million to support residential services, including community locations to achieve HIQA compliance.

In addition to these regulations, there must also be compliance with Housing Regulations (where the provider concerned is also an Approved Housing Body).

The HSE and its funded service providers operate within a buoyant and competitive housing market. Furthermore, services must be adaptable and flexible to meet various changes including, for example, responding to changing/ unmet service user need (Including clinical/ safeguarding risks) and the requirement to respond urgently to other circumstances that influence accommodation for example, the ongoing pandemic.



The central guiding principle for the disability sector is to support people to live in their community with the support required and based in will and preference as well as assessment of need.

The National Housing Strategy for Disabled People 2022 - 2027

The National Housing Strategy for Disabled People 2022 - 2027 has been developed by the Department of Housing, Local Government and Heritage(DHLGH), in association with the Department of Health (DoH) and the Department of Children, Equality, Disability, Integration and Youth (DCEDIY) under the guiding principles of Housing for *All – A New Housing Plan for Ireland*. It documents the framework for the delivery of housing for people with a disability through mainstream housing policy.

No one department or organisation can deliver on the vision of the Strategy alone. The delivery must be done in a coordinated and collaborative way, in line with the UNCRPD, with people with a disability at the centre. Delivering on "Article 19 - Living independently and being included in the community", ensures people with a disability have equal rights in accessing housing and equal rights to accessing supports necessary to enable them to live independently within the community.
