## PQ Number: 11157/22 PQ Question: To ask the Minister for Health the estimated cost of providing a liaison psychiatrist post. -Mark Ward

Dear Deputy Ward,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The Department of Health Consolidated salary scales sets out the rates payable to consultants. <u>https://www.hse.ie/eng/staff/resources/hr-circulars/1-october-2021-consolidated-salary-scales.pdf</u>

There are a number of determining factors including contract type, new entrant, on call frequency, call outs and so forth which should also be considered.

I attach for your information, the following Appendix. Table 1 represents the basic pay for each three types of contract for new entrant consultants under the 2008 Consultant Contract. The Contract provides for additional payments in respect of liability to be on call, and emergency call outs, these are also shown at Table 2.

Please Note: This is a pay cost only and a minimum of 10% non-pay costs must be added.
