The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Questions which you submitted to the Minister for Health for response.

The spread of COVID-19 has posed significant challenges for many service areas, including all Therapy Services. In light of these unprecedented challenges together with the Government's guidance on social distancing and on 'Cocooning' for those aged over 70, the HSE has had to reassess its operation of Community Therapy Services nationally, to ensure that the assessed needs of those clients with the highest priority are met.

Please find the attached appendices, which contain, in tabular form, details of the waiting list for individuals In child psychology, speech and language therapy, physiotherapy, occupational therapy, podiatry, audiology, dietetics, psychology and ophthalmology as of January 2022.
