To ask the Minister for Health the number of persons on nursing homes support scheme waiting lists by CHO at the end of 2021 and at the latest available data point broken down age and by the length of waiting time by age in tabular form.

The number of persons awaiting on nursing home support scheme waiting list by CHO the end of 2021 (29/12/2021) length of waiting time by age.


The number of persons awaiting on nursing home support as the end of 2021 was 289 and funding is approved for each client within four weeks of application approval. Details by age category are outlined within **Appendix 1**.

The number of persons on waiting list at 28/02/2022 is 744 and funding is approved for each client within four weeks of application approval. Details by age category are outlined within **Appendix 2**.
