Dear Deputy Pringle,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 12358/22

To ask the Minister for Health the actions his Department has taken to establish a working group under the joint auspices of the National Dementia Office and the Integrated Care Programme; and if he will make a statement on the matter.

There are an estimated 64,142 people in Ireland living with dementia. This number is expected to rise to 150,131 within twenty years. In line with the HSE National Service Plan (NSP) 2022, the HSE is committed to providing current and future dementia services in a flexible and person-centred way to meet the needs of the growing number of people with dementia.

The National Dementia Office (NDO) was established in 2015 and is part of the Services for Older People Change & Innovation Team. The NDO was tasked with overseeing the implementation of the National Dementia Strategy (2014). Each of the NDO's workstreams are governed by an expert advisory or steering group. Table 1 below provide an overview of current Steering Groups.
