Dear Deputy Ó Snodaigh,

I refer to the above Parliamentary Question which has been referred by the Minister for Health to the Health Service Executive for direct response. I requested that the Children's Disability Network Manager for Brú Chaoimhín (Team 1) and Children's Disability Network Manager for St. Columba's (Team 3) examine the matter and the following outlines the position.

Since the reconfiguration of children's disability services in September 2021 the CDNTs have been working hard to establish and provide equitable access to their service. The demand for the service of the CDNT to meet the intervention needs of the child population is significantly greater than the resource available. The Health Minister will be aware of the issues in relation to staff retention and recruitment in this area and the additional demands for time legislated assessments under the Disability Act (2005).

The prevailing recruitment situation across clinical disciplines is highly challenging due shortage of skills nationally. We have strived to fill the vacant posts since reconfiguration and are committed to filling these vacancies as soon as possible.
