PQ 57606/22: To ask the Minister for Health the number of adults and children on public dental and orthodontic waiting lists in October 2022 by county, region and CHO, in tabular form; the numbers by wait timebands; the average length of wait; and if he will make a statement on the matter.

Dear Deputy Cullinane,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for response.

HSE Dental Service

HSE Dental Services are provided through 17 Dental Areas, all of which continue to provide routine services. The dental service prioritises treatment for people with special care needs, those who are medically compromised and provides emergency care for all eligible patients.

I wish to advise that the system does not hold data in the manner requested. Appendix 1 details KPI data for the Dental Service (at end of October 2022). The reported metric is the number of new oral health patients in target groups attending for scheduled assessment.

HSE Orthodontic Service

Orthodontic treatment waiting lists are collated and reported according to HSE eligibility criteria Modified IOTN, Grade 4 or Grade 5.

The HSE Orthodontic Service is provided in Regional Orthodontic Departments. Access to treatment with the HSE Orthodontic Service is limited to those children with the most severe and complex orthodontic treatment needs. Referral for orthodontic assessment is usually made in 6th Class. The Modified Index of Treatment Needs (Modified IOTN) system is used in all regions to determine if a child will be accepted for treatment. There are a number of categories within the Modified IOTN system, and these are used to prioritise care, children whose treatment need is assessed as being in Grade 4 or Grade 5 of the Index are offered treatment with the HSE.

I wish to advise that the system does not hold data in the manner requested. Appendix 2 details KPI data for the Orthodontic Service (at end of Quarter 3 2022).
