The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. Your PQ above has been referred to me for response.

Please see **Appendix 1 Table 1** below which shows the total paid by the HSE to the company EHF29 Insourcing t/a EHF29 Ltd for HSE Statutory services only for the year 2021 and for the period January to September 2022. The data provided was sourced from the HSE Regional Finance ledger systems and is for HSE Statutory services only.

EHF29 Insourcing is a HSE approved company for the provision of Insourcing Services for Clinical & Surgical Procedures via the Dynamic Purchasing System Framework. EHF Insourcing provide a wide range of insourced surgical / outpatient / diagnostic waiting list initiatives.
