Breakdown of the number of Regional Health Forum & Committee West Meetings 2021:

The number of Regional Health Forum and Committee West meetings in 2021 was eight and they were all held virtually. The Regional Health Forum West office processed no payments in 2021 for the Mayo members of the Regional Health Forum West as all meetings were held virtually.

Breakdown of the number of Regional Health Forum & Committee West Meetings 2022 and expenses allocated:

To date in 2022 there have been seven Regional Health Forum and Committee West meetings held virtually and by using a hybrid model with a virtual or in-person attendance.

To date the Regional Health Forum West office has processed €744.23 for payment to the Mayo members of the Regional Health Forum West in 2022.
