**Question: To ask the Minister for Health if senior HSE management, including Chief Officers, Heads of Service and area administrators, across CHOs were offered first-dose Covid-19 vaccines in 2021 as part of the national roll-out of the Covid-19 vaccine programme to HSE staff, or as part of a separate scheduling process; and if he will make a statement on the matter.**

**Question: To ask the Minister for Health if Mental Health Service heads of discipline across CHOs were offered first dose Covid-19 vaccines in 2021 as part of the national roll-out of the Covid-19 vaccine programme to HSE staff, or as part of a separate scheduling process; and if he will make a statement on the matter.**

Dear Deputy Hourigan,

I refer to the above Parliamentary Question which has been referred by the Minister for Health to the Health Service Executive for direct response.

As advised in previous PQ responses relating to this matter I wish to confirm in 2021 there was no separate scheduling process for HSE senior management as part of the national roll-out of the Covid-19 Vaccination Programme. The date on which public servants were offered access to a Covid-19 vaccine was dependant on their alignment to the sequencing guidelines rather than their employment as a public servant, given the broad spectrum of those employed within the public service these dates would vary. HSE senior management were eligible for their vaccination when the cohort relevant to their circumstance arose.

In December 2020, the government published a COVID-19 Vaccination Strategy and Implementation Plan. This document provided the provisional sequencing in which groups were to be vaccinated. In March 2021, the government approved an update to the COVID-19 Vaccination Allocation Strategy. Based on clinical, scientific and ethical frameworks produced by the National Immunisation Advisory Committee (NIAC) and the Department of Health, this update set out the groups to be prioritised for vaccination to best achieve the Vaccination Programme's objectives of preventing serious illness, hospitalisation and death.



HSE vaccination clinics were directed to follow the scheduling in the Government Strategy. Additional guidance was put in place by the Chief Clinical Officer in scheduling appropriate staff taking into account their risk of exposure to Covid 19 in their work setting rather than their grade.
