The NAS operates on a national basis and mobilises responses to calls for assistance based on patient needs, ambulances may travel to and be dispatched from various locations irrespective of their base as they are not confined to work in geographical areas. The current deployment model is designed around international best practice and has eliminated previous practices where the nearest ambulance was not always dispatched due to former legacy boundaries.

In relation to the number of times that each ambulance service for each has had to travel 50 km or more for each month to date in 2022, the NAS does not collect the data relating to distance travelled.
