To ask the Minister for Health the number of times the adult diabetes clinic is run; the number of speciality diabetes clinics that are run, for example, a young adult clinic, type 1 adult clinic, type 2 clinic, a diabetes podiatry clinic; and if he will make a statement on the matter.

Dear Deputy O’Dea,

The Health Service Executive has been requested to reply directly to you in relation to the above parliamentary question, which you submitted to the Minister for Health for response. I have consulted with the National Clinical Programme for Diabetes on your question and have been informed that the following outlines the position.

The National Clinical Programme (NCP) for Diabetes carried out a comprehensive survey of adult diabetes services and staffing in hospitals providing outpatient diabetes care in 2018. The report can be accessed [here](#) and will provide more details on the location of adult diabetes clinics. Page 17 of the report and table 7 (copied below) provides details on types of diabetes clinics in each hospital.

This survey highlighted deficits in staffing across all professions. The survey has not been updated since 2018.


The NCP Diabetes is aware of the approval of several recent appointments (54 in total) to HSE Hospitals, comprising:

- Integrated Care Consultant Endocrinologists (n=12);
- Advanced Nurse Practitioners (n=12);
- Clinical Nurse Specialists (n=4.5);
- Dietitians (n=19.5);
- Podiatrists (n=6).

These posts are linked to the Enhanced Community Care (ECC) Programme of the HSE and assist in filling gaps in acute services to enable hospital teams to better support specialist diabetes teams based in ambulatory care hubs in the community.
