Dear Deputy Murphy,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question (Reference 42105/22), which you submitted to the Minister for Health for response.

Please see General Practitioner Assignments following 3 refusals from 2017 to 2021, also including January – August 2022. This data is broken down into county.

As you can see there is a notable increase in 2020 and 2021 much of which can be directly linked to the ongoing pandemic, migration of population from cities due to remote working, difficulty in obtaining access to GPs due to restrictions etc.

Children/Infants are primarily assigned through their parents cards. This information is included in figures below. Please note that Medical Card Applications are received primarily from a family unit, whereas if a child is over 16 a separate application is required, as does a client over 70. As such, our data is not collated in the manner you requested to provide a schedule in respect of persons aged 18 years and over.
