*The total number of patients on waiting lists for spinal fusion surgery at CHI at Temple Street who are clinically deemed as requiring surgery as of 26th August 2022 including suspensions.

**The number of patients suspended from the waiting list as patient is deemed temporarily unavailable, clinically unsuitable or has a provisional date for outsourcing for their procedure. This includes all suspensions (hospital or patient initiated).
