"To ask the Minister for Health the number of persons who were previously diagnosed with bowel cancer and who are waiting for a recommended follow-up colonoscopy in the Ireland East Hospital Group in each of the years 2020, 2021, 2022, and to-date in 2023, by each hospital and waiting time period, in tabular form."

Regional Hospital Mullingar	Regional Hospital Mullingar do not have data available on the number of persons who were previously diagnosed with bowel cancer and who are waiting for a recommended follow-up colonoscopy in each of the years 2020, 2021, 2022 and to date in 2023. The guidelines are that patients who have had bowel cancer resected with curative intent should have a Colonoscopy at Year 1, 4, 9 and then every 5 years thereafter. RHM patients are scheduled for appointment through a Surveillance Waiting List or are booked as they attend an Outpatient Appointment. Other patients may be having treatment elsewhere or be referred having had treatment elsewhere.
St Vincent's University Hospital	I have had this matter examined and am advised that colonoscopies are normally conducted by the Endoscopy Department in St. Vincent's University Hospital in a timely manner, including for those patients who require follow up and were previously diagnosed with bowel cancer. The Cancer Directorate and Clinical Support Service are currently examining ways in which data relating to patients for follow up who were previously diagnosed with bowel cancer can be isolated within the colonoscopy waiting list and reported.
St Luke's General Hospital	I wish to advise you that patients who require surveillance colonoscopy are placed on the planned surveillance waiting list in St Luke's Hospital, Kilkenny. We do not, however, have sub-categories within the surveillance waiting list of "bowel cancer diagnosis" and, therefore, I am unable to furnish you with this particular information for the years requested. The surveillance endoscopy waiting list is a standing item on the Endoscopy Governance Committee Meeting, which is convened monthly, and we have a dedicated Advance Nurse Practitioner who manages, validates and reports on the surveillance waiting list within the relevant management guidelines (BSG, CSSG & ACPGBI).
Our Lady's Hospital Navan	Our Lady's Hospital, Navan hold a surveillance colonoscopy list but not for patients previously diagnosed with bowel cancer.
St Michael's Hospital	Any patient diagnosed with Colorectal cancer is referred to the Colorectal Cancer service in SVUH for further management and we would not see them again in SMH. Therefore, we do not have a waiting list for surveillance.
Wexford General Hospital	We have a significant surveillance waiting list at Wexford General Hospital. However, it is not possible to identify how many of these patients were previously diagnosed with Bowel Cancer.
