To ask the Minister for Health if he will provide a complete list of the HSE's National Clinical Programmes from 2015 to date in 2023, including programmes no longer in operation, the names of the members of each national clinical programme, all sub-groups within each programme, such as Working Groups, Clinical Advisory Groups, and so on, in tabular form.

Dear Deputy O'Reilly,

The Health Service Executive has been requested to reply directly to you in relation to the above parliamentary question, which you submitted to the Minister for Health for response.

The information requested regarding a complete list of

- (i) the HSE's National Clinical Programmes (NCPs) from 2015 to date in 2023;
- (ii) including programmes no longer in operation;
- (iii) the names of the members of each national clinical programme;
- (iv) all sub-groups within each programme, such as (a) Working Groups, (b) Clinical Advisory Groups, and so on;
- (v) in tabular form for a nine-year period (2015-2023 inclusive)

is not collated or reported by HSE Corporate in the manner requested.

Undertaking such a voluminous request, spanning a nine-year period outlined above, would entail a time-consuming exercise and require redeployment of resources which would negatively impact both corporate and frontline healthcare service delivery.

However, what can be reasonably provided at this point in time are the details of current national clinical programmes which are correct as of this time point in 2023.

This high-level information is provided at Appendix 1.
