The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary question, which was submitted to this department for response.

**PQ: 6983/23**

*To ask the Minister for Health the disability day services centres that received funding in the past two years to provide upgrade or improving their transport provision to and from their centres.*

### HSE Response

Day Services are a key component of support services that enable clients to live within the community.

Currently almost 19,000 people are in receipt of disability Day Service supports at 1,041 locations around the country. These supports are provided by approximately 95 service provider agencies.

The funding allocated to provide for transport vehicle replacements during 2021 was allocated to disability day service provider organisations rather than to specific day centres. This approach is used as a vehicle may service more than one centre.

There was no funding provided in 2022.

Please see below which is a list of day service providers by Community Healthcare Area (CHO) that were allocated funding in 2021 for vehicle replacement.
