"To ask the Minister for Health the number of applications made under the Cross Border Directive in 2021 and in 2022 respectively; the number of these applications that were successful and the number that were not granted; to provide a breakdown, in tabular form of the procedures involved and countries involved in each year; the overall cost to the State in each of the two years; the number of successful patients awaiting payment at present; the waiting times involved for same; and if he will make a statement on the matter."

Dear Deputy Stanton,

Thank you for your parliamentary question referenced above, which has been forwarded to me for direct reply.

Under the provisions of the Directive as implemented in Ireland a patient may apply for Prior Notification, which is optional and/or reimbursement of healthcare costs. In 2021 and 2022 the number of applications for Prior Notification were 293 and 94 respectively. Prior Notification applications are applications where a patient is seeking confirmation of the estimated value and confirmation of compliance with public patient pathways in advance of proceeding with inpatient care.

In 2021 and 2022 the number of applications for reimbursement were 1,914 and 1,041 respectively. The cost of reimbursements to patients in 2021 was \in 7,811,327 and in 2022 it was \in 4,323,231.72.

In understanding these figures it should be noted that the COVID-19 pandemic impacted patients' ability to travel to access healthcare.

In 2021 of the 2737 applications for reimbursement processed, of these 1914 were approved and 148 were declined.

In 2022 of the 1145 applications for reimbursement processed, of these 1041 were approved and 104 were declined.

All applicants whose application for reimbursement are declined are notified of the right to appeal that decision. In addition, applicants who are approved are advised they may appeal the value of the reimbursement.

In 2021 166 appeals were received. 113 of these had the original decision upheld and 53 had the original decision overturned. This equates to 34% had the decision overturned at appeal stage.

In 2022 101 appeals were received. 67 of these had the original decision upheld and 33 had the original decision overturned. This equates to 33% had the decision overturned at appeal stage.

Backlog

The CBD and NIPHS offices as at 14th Feb 2023 are currently operating with a 3 month backlog (currently processing applications received in Nov 2022). It is estimated there are 1,500 applications awaiting processing as at 14/2/2023. This is a cause for concern in relation to delivering a quality patient service.

Resources

When the CBD and later the NIPHS were introduced the HSE did not receive specific resources to operate the schemes. In 2020, the then National Director Acute Hospital Services approved 22 WTEs to operate the scheme effectively regularising/approving the staffing level operating the schemes at that time. The approved staffing level was appropriate to the 2020 and 2021 level of activity, which was significantly reduced reflecting travel restrictions due to COVID-19. Of the 22 WTEs only 7 staff members have actually been recruited and taken up post. The offices rely on agency staff resulting in high turnover of trained staff when trained agency staff leave to take up permanent positions elsewhere.
