“To ask the Minister for Health the total funding for HSE dental services in the past five years in all LHOs in CHO4; the number of children waiting for dental services in these LHOs; their waiting times; the location in which children in these LHOs can have orthodontic treatment carried out; the number of orthodontists available to the HSE in these areas; the criteria being applied that determines whether a child qualifies for HSE funded orthodontic treatment; the number waiting for same; and if he will make a statement on the matter.”

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

Cork Kerry Community Healthcare by LHO

As a result of the COVID pandemic and the suspension of Dental School Screening Programme in Cork and Kerry, for a protracted period, Cork Dental Service is currently only screening 6th class children. The school screening of 6th classes is behind schedule. The number of children yet to be seen in Cork is as follows:

The number of 6th class patients waiting for assessment as part of the Dental School Screening Programme in Cork and Kerry is 15,490 children. In addition when we catch-up we will add the 2nd class in each LHO to this total, amounting to circa 10,000 children, which would bring the total to 25,490 children.

The current number of children waiting for orthodontic assessment in Cork and Kerry is 3,093, and the current wait time is 12 months for attention (priority 1) assessment and 3 years for routine assessment (non-urgent). There are 2 consultant orthodontists, 6 specialist orthodontists and 3 senior admin dental surgeons with specified duties in this area. Patients referred from Cork North Lee/South Lee and Kerry have their orthodontic treatment in the HSE Orthodontic Department, St. Finbarr's Hospital, Douglas Road, Cork. Patients from North Cork have their orthodontic treatment in the Cork University Dental Hospital, Wilton Cork. Qualification for treatment is determined by nationally agreed eligibility guidelines based on an international grading system (IOTN). All referrals for the service are triaged and given a priority rating by the clinical team.
