Dear Deputy Cullinane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

**Response:**

In relation to the collection of data associated with hospital cancellations for scheduled care activities in the context of your questions above. Hospitals and Hospital Groups working with the HSE worked in 2022 to develop a robust process for the collection and collation of data on cancellations. Data collection commenced in February 2022 and over the subsequent months became streamlined and now forms as part of a robust process that is in place for weekly collection of data associated with Hospital initiated cancellations.

In this context no information is available prior to early 2022 as the information was not collected centrally. In addition, the current information collected does not differentiate between children and adults however it does breakout cancellations by site including CHI locations and has been provided.

The following information has been provided:

- Hospital-initiated scheduled care cancellations in January 2023 to date, by hospital group, hospital and by appointment type in tabular form.
- Hospital-initiated scheduled care cancellations, by appointment type for the full year of 2022 and for each month, by hospital group and hospital in tabular form
- Hospital-initiated scheduled care cancellations, by appointment type in January 2023 to date, for children by hospital group and hospital in tabular form.
- Hospital-initiated scheduled care cancellations in December 2022, by hospital group, hospital and by appointment type in tabular form
- Cancer related appointments and procedures which were cancelled in each month of 2022, by hospital including both HSE and voluntary hospitals in tabular form.

**Definition of a hospital initiated inpatient/day case cancellation:**

A hospital-initiated cancellation of an outpatient or inpatient/day case procedure is defined as the rescheduling of a patient To Come In (TCI) date by the hospital due to circumstances beyond its control. It is important to note that the cancellations included in the report could represent in some cases patients who have been cancelled on more than one occasion.

**Reasons for cancellation of scheduled care appointments:**

Hospitals may have to cancel scheduled care appointments due to factors outside their control including the following:

- I. Increased ED attendances and admissions resulting in a requirement for surge inpatient bed capacity.
- II. Unforeseen circumstances e.g., Weather events, infection outbreaks or industrial action.
- III. Sick leave which impacts on service being given at the planned time

**Rescheduling hospital appointments:**

Hospitals endeavour to provide the patient with as much notice as possible in relation to the cancellation of elective appointments. The National Inpatient, Day Case, Planned Procedure (IDPP) waiting list management protocol 2017 issued by the National Treatment Purchase

Fund (NTPF) requires hospitals to reschedule elective care appointments within six weeks of cancellation, subject to patient confirmation regarding their availability to attend. Clinical guidance must be sought when managing and rescheduling patients cancelled by the hospital. This is necessary to ensure that urgent and vulnerable patients are rescheduled appropriately. Patients cancelled by the hospital will not have their waiting list date reset.
