Dear Deputy O' Dowd,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 33330/23

To ask the Minister for Health to outline the total budget for homecare provision over the years 2020 to date, in tabular form, by CHO, county, number of hours requested by homecare management, number of hours provided and the total expenditure per county; and if he will make a statement on the matter.

The Home Support Service is funded by Government to deliver a volume of service each year as approved in the HSE National Service Plan. It is a non-statutory service and access to the current service is based on assessment of the person's needs by the HSE and having regard to the available resources and the competing demands for the services.

Despite the significant level of service provision, the demand for Home Support, and its importance as an alternative service to long stay care, has grown considerably over the past number of years. Similarly, the type of Home Support that is now required to meet the needs of the population is a more person-centred personal care model. Home Support services are provided by both directly employed Healthcare Support Assistants (HCSAs) and by Approved Providers with formal tendered arrangements with the HSE, arrangements which encompass both commercial and voluntary providers.

In terms of the requested information, NSP target for 2023 has been amended from 23.9m hours to 22.0m hours (full year target) with the establishment of the Home Support Authorisation Scheme that commenced on 14th August 2023 on foot of the 2023 Tender process.

The most up to date activity reflects the period up to 30 June 2023, (latest available data) which indicates that 10,548,049 home support hours were delivered, an increase of 374,274 hours (+3.7%) when compared to the same period last year. The range of hours and types of service provided is based on the individual client's care needs assessment and varies accordingly. Please note that this data is preliminary and may be subject to change.
