Dear Deputy Gould,

The Health Service Executive has been requested to reply to you in the context of the above Parlimentary Questions, which you submitted to the Minister for Children, Equality, Disability, Integration and Youth for response.

Children's Disability Network Teams (CDNTs) have been established to provide services and supports for all children with complex needs within a defined geographic area.

A child's access to services is based on his/her needs and therefore a diagnosis is not required. Instead of a service providing for children with one type of disability only, resulting in some children unable to access a service, each CDNT provides for all children with complex needs arising from their disability who live in that area. Children with non-complex needs receive services at Primary Care level.



Currently, the teams have large numbers of complex children on their caseloads who require an interdisciplinary team approach and this is provided on a needs basis due to priority and risk to child, young adult and family in all environments such as home, school and in the community.

Regrettably, I am unable to provide a breakdown of data on those awaiting a specific intervention as at any one time. The team works in an interdisciplinary way i.e. a number of professionals of different disciplines working together with the child and family, sharing information, decision-making and goal-setting. This is a change from the previous model where a child accessed one discipline at a time and statistics were available in the manner requested.

Today a number of children may be in receipt of some intervention(s) but may also be waiting for another intervention(s) and without adequate ICT systems we are unable to provide the level of detail you have requested. I can advise that Cork CDNT's at the end of June 2023 had an active caseload of 5,679 children.
