Re PQ 35040 23: *To ask the Minister for Health to outline the portion of HSE spend on Section 38 and Section 39 organisations that covers pay; the total HSE spend on funding such organisations in 2022; and if he will make a statement on the matter.*

Dear Deputy Cullinane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Questions, which you submitted to the Minister for Health for response. Your PQ above has been referred to me for response.

Please see Appendix 1 grants to outside agencies – section 38 & 39s for the year 2018 to 2022 inclusive.

The 2023 Budget allocated to section 38 and section 39 organisations is not available at this point in time. The yearly budget is allocated to section 38 and 39 organisation by each of the Community Health Organisation at local level. The central financial information systems do not capture this on a real time basis. The totality of grants paid to outside agencies are collated and verified as part of the process of preparation of the Annual Financial statements and year end audit. The HSE does not capture the portion of HSE spend allocated to pay by these organisations.

The shortcomings in the HSE legacy financial systems are well acknowledged and their replacement by a single standard financial system for the Health Sector is at the core of the Finance Reform programme initiated by the Department of Health.
