PQ 26984/23 - To ask the Minister for Health the extent to which school health examinations continue including dental and ophthalmic; and if he will make a statement on the matter.

Dear Deputy Durkan,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question (PQ 26984/23) which you submitted to the Minister for Health for response.

With regard to dental services, the HSE targets children in key school years (2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> classes), offering them dental examinations, preventive care and restorative treatments for conditions noted. Children in targeted classes are offered dental examination, with individual care plans based on each child's needs. For routine and preventive services, patient groups are prioritised with children and adults with special care needs given the highest priority, followed by children in 6th class. As part of targeting of resources, each dental service maintains a commitment to urgent/emergency treatment. The most recent available data in relation to the Dental service is collated in the following format:
