The provision of HSE Community Nursing care is an important component of healthcare delivery and comprises of both long and short stay residential care facilities.

The attached file includes information, in the tab labelled **Bed Capacity**, on each registered HSE, Section 38 funded and Section 39 funded voluntary nursing home in respect of the years 2021 and 2022. The total bed capacity comprises both long and short stay beds.

The tab labelled **Public_S38** provides a breakdown of the cost of provision to the NHSS per Public and Section 38 funded nursing homes for 2021 and 2022. These costs are based on the payments from the NHSS only to the Nursing Homes for 2021 and 2022 in respect of clients supported through the scheme

The tab labelled **Private_S39** provides a breakdown of the cost of the provision to the NHSS per Private and Section 39 funded Nursing Homes for 2021 and 2022. These costs are based on the payments from the NHSS only to the Nursing Homes for 2021 and 2022 in respect of clients supported through the scheme. These nursing homes have a price agreement with the National Treatment Purchase Fund.
