To ask the Minister for Health if he will identify the placement alternatives for the client group under the care of the Laois/Offaly mental health services who either currently reside at a facility (details supplied), or for whom the facility is their nearest 24-hour staffed facility; the distance from Rathdowney of each of these facilities; if he will provide details on how each of these facilities meet the requirements of the HSE Design for Mental Health Guidelines, by which the facility was recently judged in an architect's report; and if he will make a statement on the matter

Dear Deputy Hourigan

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and I outline the position as follows.

Mental Health Services in Laois Offaly operate the following High Support Community Residences (24 Hour Staffing).
