Services for Older Persons

Residential Services:

Occupational Therapy (OT) services to our residential units are provided through our colleagues in Primary Care under the clinical governance of an Occupational Therapy manager where the unit is based. Vacancies are identified and filled by the relevant OT manager and allotted to care groups including Services for Older Persons as required. Currently there are no identified vacancies in the OT services provided for our residential units.

Non- Residential Services:

Within Non-Residential Services for Older Persons, the Integrated Care Programme for Older Persons (ICPOP) has a number of OT posts. The table below sets out the position as at February 2023:

Mental Health Services

Disability Services for Older Persons

HSE Disability Services in CKCH provides funding to Lead agencies through Service Level Agreements. Lead agencies are responsible for recruitment of staff within their organisation and the HSE does not hold HR records for these agencies. Therefore, HSE CKCH Disability Services is unable to advise if posts are filled on a full-time or part-time basis.

The HSE is currently experiencing difficulties in recruiting across all therapy grades, particularly in respect to entry therapy grades. There have been significant career opportunities across all therapy grades following national developments in the healthcare area such as the Enhanced Community Care Programmes and the Integrated Care Programmes in Chronic Disease and Older Persons. Our academic institutions provide graduates on an annual basis and this normally facilitates our requirements for registered therapist recruitment to our services however, the recent/current demand for suitably qualified candidates exceeds the supply available to the services. In this regard the HSE, at both local and national level, has embarked upon an international workforce planning exercise with an emphasis on the recruitment of scarce therapy grades. This was consolidated during June 2022 when an amendment to the current legislation governing international work permit applications was enacted whereby, these grades have been included under the Critical Skills Permit process. A HSE International Recruitment Framework is also now in place which has provided an avenue for recruitment for these grades. Our HR staff continue to explore all options to enhance the recruitment of these grades.
