The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary question, which was submitted to this department for response.

PQ: 20897/23

To ask the Minister for Health the number of children on waiting lists for an assessment of need at the end of quarter 1 2019-2023, inclusive, in tabular form; the number overdue for completion; and the average length of wait.

HSE Response

The Assessment of Need process is set out in the <u>Disability Act, 2005</u>. The aim of an Assessment of Need under the Disability Act is to identify whether a person has a disability, the nature and extent of the disability, any health and education needs arising from that disability, as well as what services are required to meet those needs.

The numbers of applications for AON under the Act have risen steadily since its implementation in June 2007. 7144 applications for AON were received in the most recent 4 quarters (Q2, 2022 – Q1 2023. This was the highest number of applications received in any 12 month period since Part 2 of the Act was commenced in June 2007.

The HSE has endeavoured to meet its legislative obligations under the Act. However, as a consequence of a High Court ruling of December 2009, the effect of which was to open eligibility to all persons born after 1st June 2002 who are suspected of having a disability, the number of children aged five and over, and in addition of school-going age, has risen steadily as a percentage of all applications received. At the end of 2011, the figure stood at 26%, while throughout 2022, this figure averaged 55%. This is a reflection that the AON process is an accumulative process in terms of numbers of children and young people seeking access.

Please see tables 1 to 5 provided in the Appendix. Assessment of Need reports are available on a Quarterly basis, these tables are taken from the Quarter 1 (January, February, March) Assessment of Need report for each year 2019, 2020, 2021, 2022 and 2023.

The judgement of Ms Justice S Phelan in the case of CTM & JA v the HSE found that the Preliminary Team Assessment approach described in the HSE's Standard Operating Procedure for Assessment of Need does not meet the requirements of the Disability Act. This judgement in effect requires the HSE to deliver diagnostic assessments where necessary and appropriate as part of the Assessment of Need process. This ruling has a significant impact operationally and has resulted in a growth in the numbers of overdue Assessments of Need. The requirement for services to prioritise

the statutory Assessment of Need process will also impact significantly on their capacity to provide necessary intervention / treatment for children with disabilities.

The HSE is continuing to review the files of all children who received a preliminary team assessment and engaging directly with families to establish what additional assessments will be required to meet the requirements of the Act. Additional funding has been secured to support the additional assessments required. Some assessments have been procured from the private sector and further procurement is planned.

The HSE's National Clinical Programme for People with Disability (NCPPD) has led the process of developing Interim Clinical Guidance to replace the element of the Standard Operating Procedure which was found to be non-compliant with the Disability Act (2005) – the Preliminary Team Assessment. This guidance has been reviewed by the HSE's and Department of Health's legal advisors and feedback provided. It has also been agreed with staff representative bodies. It is now being finalised by NCPPD and a date for circulation will be agreed following this.

The NCPPD has also committed to establishing a Task Group on Assessment of Need to address other issues related to the Assessment of Need process that are not addressed in the Interim Clinical Guidance. This group will include representatives from all the key stakeholders and particularly those with lived experience, and will meet monthly over the next 12 months.

The HSE is committed to the delivery of appropriate services for children with disabilities and working with families and staff to develop services that meet their needs. It is important to note that children do not require an Assessment of Need to access health services and parents may refer their child directly to their local Children's Disability Network Team (CDNT).
