Dear Deputy Shortall,

The Health Service Executive has been requested to reply directly to you in relation to the above parliamentary question, which you submitted to the Minister for Health for response. I have consulted with the National Clinical Programme (NCP) for Diabetes on your question and have been informed that the following outlines the position.

Limb loss is one of the most devastating complications of diabetes and represents an enormous burden on the individual, their families and on the health and social care system in general. In addition, diabetic foot disease accounts for a significant proportion of health service expenditure. Reducing the number of diabetes related foot ulcers and amputations remains one of the NCP Diabetes major aims.

The first Model of Care to be published by the NCP Diabetes was the Model of Care for the Diabetic Foot 2011, which has been further updated and re-launched in December 2021. In line with international best evidence it calls for an equitable standardised foot screening process, risk status to be defined and a clinical care and management plan to be recommended for each category. It calls for initial foot screening to occur in general practice, the at –risk foot to be treated in the community setting by the foot protection team and the active foot to receive care in the hospital setting by the multidisciplinary diabetic foot team.

The NCP for Diabetes updated the Model of Care for the Diabetic Foot (2021) with a view to clarifying the roles and responsibilities of the various members of the multidisciplinary team involved in managing patients with (or at risk of) foot ulceration. This updated Model of Care emphasises the importance of joined up working across primary, secondary and tertiary care with clarification of referral pathways between the different sectors.

In line with the vision set out by Sláintecare, the HSE Enhanced Community Care (ECC) programme is a new, targeted reform programme that aims to resource and scale-up community healthcare services nationally, including specialist diabetes teams (podiatrists, dietitians and nurses), in line with the National Framework for the Integrated Prevention and Management of Chronic Disease in Ireland (2020-2025).

As part of this initiative, extensive funding has been secured to develop 30 specialist ambulatory care hubs that will each serve approximately three community healthcare networks [CHNs] (a population of approximately 150,000). These hubs will deliver specialist services to all eligible patients, thereby supporting General Practices (GPs) to provide a spectrum of care enabling people with chronic disease to be cared for in the community.

To enhance diabetes care in the community, each specialist ambulatory care hub will be resourced with the following diabetes specialist staff:

- Three (3) Clinical Nurse Specialists Diabetes Integrated Care;
- Three (3) Senior Dietitians (Diabetes);
- Three (3) Staff Grade Dietitians (Diabetes Prevention);



• Three (3) Podiatrists (comprising 1 Clinical Specialist, 1 Senior Podiatrist and 1 Staff Grade Podiatrists).

Specific data information for each of the PQs listed above is included in a number of tables below.

Notes:

The figures quoted include data from all publicly funded acute hospitals which were included on the Hospital In-patient Enquiry (HIPE) system during 2020, 2021 and 2022.

In-patient and day case discharges are reported only; ED and Out-patient attendances are not recorded on HIPE. Patients of No Fixed Abode or not normally resident in Ireland have been excluded.

It is important to note that this data is based on hospital discharges only and does not include patients undergoing treatment who are not admitted to hospital. 2020, 2021 and 2022 data does not include public activity which was conducted in private hospitals under the private hospitals contracts.

Furthermore, the data is based on hospitalisations which may include multiple admissions for the same patient. Therefore the data presented here cannot be construed as an estimate of the prevalence of the treatment specified.

For every discharge HIPE captures a principal diagnosis and up to 29 additional diagnoses, and up to 20 procedures, in addition to administrative and demographic information.

Diagnosis and Procedures are coded using ICD-10-AM/ACHI/ACS (1015-1019 used the 8th edition. From 2020 the 10th edition is used).

ICD-10-AM is the International Statistical Classification of Diseases and Related Health Problems, Tenth Revision, Australian Modification.

The ICD-10-AM disease component is based on the World Health Organisation (WHO) ICD-10. ICD-10-AM is used in conjunction with the Australian Classification of Health Interventions (ACHI), and the Australian Coding Standards (ACS) to reflect an accurate health episode of care.

Definitions used:

Full or Partial lower limb Amputation: any procedure with a code of 44367-01 Disarticulation at knee, 44367-02 Amputation below knee, 44370-00 Amputation at hip, 44373-00 Hindquarter amputation, 44367-00 Amputation above knee,

44338-00 Amputation of Toe, 44358-00 Amputation of toe including metatarsal bone, 90557-00 Disarticulation through toe, 44361-00 Disarticulation through ankle, 44364-00 Midtarsal amputation,

44364-01 Transmetatarsal amputation, 44361-01 Amputation of ankle through malleoli of tibia and fibula

Diabetes: any diagnosis with a code of E10 Type 1 Diabetes, E11 Type 2 diabetes, E13 Other specified diabetes mellitus, E14 Unspecified diabetes mellitus **County**: The county of residence code identifies the place where the person would normally reside, i.e. 'home address'. Those from a foreign country that are now resident in Ireland would have a code assigned for where they now live in Ireland.

Bed Days: number of days between admission date and discharge date, where admission date is equal to discharge date the bed day has been set to 0.5 days
