Dear Deputy Grealish,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 24219/23

To ask the Minister for Health the number of allocated home support hours that cannot be filled, by LHO and CHO; and if he will make a statement on the matter. -Noel Grealish

The Home Support Service is funded by Government to deliver a volume of service each year as approved in the HSE National Service Plan. It is a non-statutory service and access to the current service is based on assessment of the person's needs by the HSE and having regard to the available resources and the competing demands for the services.

Despite the significant level of service provision, the demand for Home Support, and its importance as an alternative service to long stay care, has grown considerably over the past number of years. In the context of increasing demand, priority is given to those being discharged from acute hospitals who are in a position to return home with supports and to those in the community with acute needs. The overall home care resource and the range of providers, including HSE directly employed staff, is carefully managed by the local Home Support Management Team within each Community Healthcare Organisation, to ensure that this key service is available at the required times, in a flexible way and at the appropriate standard to support clients' assessed needs.

Recruitment and retention of home support staff for both direct and indirect service provision remains a significant challenge leading to capacity issues cross the Community Healthcare Organisations (CHOs). The HSE continues to advertise on an ongoing basis for Health Care Support Assistants (HCSAs) and recruits as many suitable candidates, where possible. The HSE conducts its recruitment through a variety of channels both at local level and through the shared service offices of HBS. Due to the nature of Health Care Support Assistants, recruitment is routinely conducted at a local level and is on-going across the HSE in an effort to ensure availability of carers.

In terms of the requested information, we do not collate data on unallocated Home Support hours. The latest available data relates to the year to date period up to the 30th of April, 2023.
