### Dear Deputy,

I refer to your recent Parliamentary Question which was sent to the HSE for response.

To advise that Deputy that the Special Pandemic Bonus Payments Scheme was managed by two processes – 1. Public Sector Cohort and 2. Non-Public Sector Cohort. Please see detail below for each of these two cohors.

## 1. Public Sector Cohort: (HSE and S38 Agencies)

The data below was reported to us centrally from **HSE Payroll areas**:

No of approved applications *	90,632
Payments processed	90,632
Value of payments made	€87,776,190

**S38s:** The above data excludes S38 agencies which are estimated to have paid approximately 53,146 staff to date thereby bringing the total number of employees to **143,778**. The estimate of S38 agency employees paid to date is based on vouched information received directly from the agency in response to a request from National HR to provide information on the total number of staff actually paid the pandemic bonus payment to date. Payment is now complete for this cohort.

# 2. Non-public sector cohorts:

HSE and external contractor KOSI Corporation are rolling out the payment to cohorts 1-4 (as per table below)

As of 22/09/23, funding to 746 organisations for 77,744 staff has totalled €70.3m:
