Dear Deputy Murphy,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Questions, which were submitted to the Minister for Health for response.

I have reviewed the matter and the following Composite Response outlines the current position.

The following table sets out total number of Intellectual disability respite beds in County Wexford:

Service Provider	No. of Respite Beds			
Reachability	5 Adult			
Ard Aoibhinn	8 (4 adult and 4 children)			
St. Aidan's	7 (adults & children – demand led)			
Total	20			

One St. Aidan's bed is a designated unplanned emergency admission bed and is filled in consultation with Disability Services.

Ard Aoibhinn is open four nights a week for children and six nights a week for adults. Reachability is providing services three nights per week.

Houses may not run at full capacity due to client need, assessed risks and compatibility issues at any given time.

There are no designated Physical and Sensory beds. Application is made to Nursing Homes on an ad hoc basis as need arises, some referrals are made to Cheshire Waterford.

There are no vacant beds other than the unplanned admission bed which is filled as needed to meet emergency need.
