Dear Deputy Connolly,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

As previously communicated, a number of property transactions are required to facilitate this development. These involve the transfer of land from Galway County Council to the Department of Rural and Community Development, and the subsequent transfer of a portion of that land from the Department of Rural and Community Development to the HSE for the purpose of a primary care centre.

Galway County Council have advised the HSE that the disposal of lands from Galway County Council to Department of Rural and Community Development was approved by Councillors at the June Plenary Council Meeting. Legal Agents for Galway County Council are progressing with this matter as swiftly as possible.

It will be possible to provide a more definitive timeframe for the acquisition of the site by the HSE when the legal processes associated with the transfer of the lands to Department of Rural and Community Development concludes.



In parallel with, and subject to land transfer activities, the HSE intend to progress the appointment a design team to advance this healthcare facility. The delivery of a primary care centre on Inisbofin remains a priority for the HSE, subject to resolution of site acquisitions as noted above, and the related matters of statutory approvals and availability of capital funding for the project.
