Dear Deputy Burke,

The Health Service Executive has been requested to reply to you in the context of the above Parlimentary Question which you submitted to the Minister for Children, Equality, Disability, Integration and Youth for response.

Children's Disability Network Teams (CDNTs) have been established to provide services and supports for all children with complex disability needs within a defined geographic area. The Government has prioritised the reinstatement of health and social care supports in special schools. In that regard, Cork Kerry Community Healthcare (CKCH) is continuing to engage with its CDNT lead agencies to progress this work.

St. Killian's Special School is aligned to Children's Disability Network Team CDNT 8 which has a caseload of 563.

The HSE and its Section 38 and Section 39 Lead Agencies are operating in a very competitive global market for healthcare talent as there are significant shortages of qualified healthcare professionals across the globe. This is impacting on full delivery of targeted hours to special schools.

CDNTS services in Cork have an average vacancy rate of 23%, with some CDNTs experiencing higher vacancy rates than others. When maternity leave and other statutory leave is included this rate increases to 32%.

A targeted national recruitment campaign has been undertaken to recruit to CDNT vacancies across the country. Lead agencies in this area are currently finalising the appointment of staff recruited through this campaign.
