PQ 17747/25\*To ask the Minister for Health further to Parliamentary Question No. 1837 of 19 March 2025, to clarify the way in which the HSE distinguishes between domestic and non-domestic facilities; and if she will make a statement on the matter. -Claire Kerrane

Dear Deputy Kerrane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

I propose to address both Parliamentary Questions with this one response.

*In Disposal:* These properties are surplus to the HSE's requirement and are in various stages of disposal in line with the HSE's Property Protocol. A property in disposal can encompass a number of phases whilst adhering to relevant circulars and protocols:

## Transfer or Share with another public body

**Step 1:** Where a surplus property is located in an urban area with a population of over 10,000 people, it is offered to the Land Development Agency in line with Section 53 of the LDA Act.

**Step 2:** The property is offered to all State Stakeholders via the OPW State Property Register (PMRV) in line with the Department of Public Expenditure, NDP Delivery and Reform Circular 11/15 (Protocols for the Transfer and Sharing of the State Property Assets)

## Disposal on the Open Market

Where no State Stakeholder has expressed an interest the property is disposed of on the open market in line with HSE Property Protocol.

**Retained Assets:** Properties that are vacant and have been retained for varying reasons. Decisions, informed by Service Management are based on an understanding of current or future healthcare service needs in the relevant area. A building may be vacated by one service with a view to refurbishment for an alternative use, or a property may be maintained for future service expansion at a specific location for demographic or service requirements. The vast majority of properties are located on large, occupied and live healthcare campuses so therefore cannot be disposed off.

With regards to the previous response issued to your Parliamentary Question No. 1837 of 19<sup>th</sup> March 2025 (responded to on 02<sup>nd</sup> April as PQ 12320-25 & 12321-25), the HSE was asked to provide the number of HSE-owned "houses" that are currently vacant, by county. The data provided in that response related specifically to "houses" which had been in use by the HSE as Residential/Domestic properties. That is distinct from "house" type structures which the HSE may have used as a Health Centre, office accommodation etc.

I trust the above clarifies this matter.
