To ask the Minister for Children; Equality; Disability; Integration and Youth for the children's disability network team staffing levels, by discipline and by grade and per population size served, in each integrated health area of the Dublin and south east regional health area as of 1 April 2025.

Dear Deputy Quaide,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which was submitted to the Minister for Health for response.

I have reviewed the matter and the following is the current position.

In line with the Progressing Disability Services model, Children's Disability Network Teams (CDNTs) are aligned to Community Healthcare Networks (CHNs) across the country and are providing services and supports for children aged from birth to 18 years of age. Each CDNT covers a specific geographical area and holds a waiting list for children with complex needs residing in that area. The model of service for all CDNTs is family-centred and based on the needs of the child. This includes universal, targeted and specialised supports and interventions, as appropriate to the individual child and family. It is based on the objectives of empowering and supporting parents and others who are with the child on a daily basis to facilitate the child's developmental needs.

Appendix 1 attached provides the approved staffing levels for the CDNTs across the integrated healthcare areas in HSE Dublin and South East. In addition, the population of children and adolescents is also provided.

The CDNTs are currently providing services and supports for children where staffing resources allow. However, there are significant challenges for CDNTs including:

- Staffing challenges
- Growth in numbers of children with complex needs as a result of their disability.
- Growth in demand for Assessment of Need

As with other areas, Disability Services continue to experience significant recruitment challenges. The HSE is operating in a very competitive market as there are significant shortages of qualified healthcare professionals nationally and internationally. HSE Dublin and South East continue to prioritise disability posts for all disciplines and to express posts out to current national panels where relevant.



The HSE optimises multiple applicant engagement opportunities to encourage uptake of CDNT vacancies including recruitment fairs, outreach to third level colleges and secondary schools, presence at national events and virtual engagements.

The HSE acknowledge that waiting times for CDNT service at this time are not appropriate and stressful for children and their families and will continue to explore a range of options to enhance the recruitment and retention of essential staff into our CDNTs.
