Donegal Mental Health Service (DMHS)

DMHS do not currently have a CAMHS MHID Consultant in place, however this post is actively being recruited by HR. This post was advertised on 24th June 2024, the closing date was extended to 30th January 2025. One candidate applied for this position, but subsequently withdrew their application.

Approval has been received to recruit a CAMHS MHID Clinical Nurse Specialist which will be progressed in the coming weeks.

The CAMHS Service have also submitted a business case to secure funding for a complete CAMHS MHID Team. When this funding is in place CAMHS will be in a position to provide CAMHS MHID Services.

<u>Cavan Monaghan Mental Health Service (CMMHS)</u>
CMMHS do not currently have a CAMHS MHID Consultant in place. CMMHS have no approval for the recruitment of a CAMHS MHID Consultant at this time.

Sligo Leitrim Mental Health Service (SLMHS)
SLMHS do not currently have a CAMHS MHID Consultant in place, however this post is being actively recruited by HR. This post was advertised, the advertisement closed on 30th January 2025 with one application received however the candidate withdrew their application following shortlisting. The post will be re-advertised when Stage 1 Approval is obtained from the REO.
