### **Question**

**To ask the Minister for Health if her Department, or any body under its aegis, currently outsources cleaning services and/or service officer/security officer roles to private companies; the value and length of any related contract, by body, in tabular form; and if she will make a statement on the matter. -Denise Mitchell**

### **Response**

Dear Deputy,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question which you submitted to the Minister for Health for response.

A mixture of contracted third-party providers, agency staff and HSE staff currently provide cleaning and security services across the thousands of healthcare facilities in Ireland. The Office of Government Procurement (OGP) is responsible for the procurement of cleaning and security services across the public sector, and as such, has first-line responsibility for procuring these services on behalf of health facilities where it is necessary to contract a third-party provider for these services. From time to time, HSE Procurement takes responsibility for individual tenders within healthcare which have not been prioritised by OGP.

The objective when tendering for these services is to procure a supplier that will provide:

- a quality-driven, cost-efficient service which achieves an optimum standard for all required areas appropriate to their use;
- a standard of service that provides a positive image of the facility and a level of cleanliness and security which ensures a clinical and socially acceptable environment for patients, visitors and staff;
- a managed service with an ongoing audit and monitoring system to ensure that the standards remain in line with accepted HSE standards and that any reduction in the quality of service is recognised and corrected.
- service activities that are lawful and compliant with current legislation, official guidance and best practice.

Please see attached a list of the current cleaning and security contracts in healthcare.
