## Re: To ask the Minister for Health the patient capacity levels in a hospital (details supplied); the number of times this was exceeded in January 2025, by patient levels, in tabular form; and if she will make a statement on the matter. -Barry Ward

Dear Deputy Ward,

I am writing in response to your PQ regarding patient capacity levels at St. Michael's Hospital and the number of times capacity was exceeded in January 2025.

To provide context to the below data it is necessary to understand that when demand exceeds capacity, elective activity in the hospital is reduced. In St. Michaels this means that the 5-day elective surgical ward is converted to a 7-day ward and accommodates unscheduled patients rather than elective surgery. The data below outlines by date the volume of surgical beds used for escalation during the month of January 2025.

In summary:

• The 5-Day Surgical Ward has a standard capacity of 18 beds and has been in surge escalation since 31 Dec 2024.

• On 16th and 17th January, escalation peaked at 22 additional patients requiring the use of 4 additional escalation beds in the Endoscopy Day Ward (Ward 3) as per the hospital escalation plan.
