The Health Service Executive has been requested to reply to you in the context of the above Parliamentary Question, which you submitted to the Minister for Children; Equality; Disability; Integration and Youth for response.

Children's Disability Network Teams (CDNTs) have been established to provide services and supports for all children with complex disability needs within a defined geographic area. A child's access to CDNT services is based on their level of need. Children with non-complex needs receive services at Primary Care level.

CDNTs provide interdisciplinary supports for children with complex needs and their families; a number of professionals of different disciplines working together with the child and family, sharing information, decision-making and goal-setting. They do not maintain waiting lists for individual disciplines. Currently, CDNTs in Cork and Kerry have large numbers of children with complex disability needs on their caseloads. These children require an interdisciplinary team approach and this is provided on a needs basis due to priority and risk to child, young adult and family in all environments such as home, school and in the community.



At the end of January 2025, Children's Disability Network Teams had 699 children awaiting an initial appointment. The table in appendix 1(a) provides a breakdown of data on initial contact waiting times by CDNT in this region. Appendix 1(b) provides CDNT geographical area and lead agency details.
