**PQ 35571/25**: To ask the Minister for Health the number of WTE senior podiatrists and WTE basic grade podiatrists employed by the Health Service Executive, in the years 2022, 2023 and 2024; the number of those employed by RHA area; and if she will make a statement on the matter.

Dear Deputy Mac Lochlainn,

I refer to your recent parliamentary question in relation to staffing which was forwarded to the Health Services Executive (HSE) by the Department of Health for direct reply.

The Health Services Personnel Census (HSPC) is the official report on direct employment in the provision of Health & Social Care Services by the HSE and the various Section 38 hospitals & agencies. Staff are reported on the basis of staff category, grade group and grade. For the purposes of this PQ the relevant staff category is Health & Social Care Professionals and grade group of Podiatrists & Chiropodists. HSPC details at the end of December 2024, show that were 127 WTE directly employed in the provision of our services under this grade group.

The table below shows the RHA area (Region), as of December 2022, December 2023 and December 2024 of each of the grades under Podiatrists & Chiropodists throughout our services:
