**To ask the Minister for Health the number of people with diabetes on a waiting list by hospital group, in the years 2022, 2023 and 2024; the number of those waiting less than six months, between 6-12 months, and more than 12 months; and if she will make a statement on the matter.**

Dear Deputy Mac Lochlainn,

The Health Service Executive has been requested to reply directly to you in relation to the above parliamentary question, which you submitted to the Minister for Health for response. I have consulted with the National Clinical Advisor and Group Lead for Chronic Disease (NCAGL CD) on your question and have been informed that the following outlines the position.

Waiting times for diabetes scheduled care services are largely reported under the umbrella of endocrinology OPD waiting times and therefore the data pertaining specifically to diabetes OPD waiting times isn't available. Combined adult endocrinology and diabetes waiting list data for the years 2022, 2023 and 2024 are presented in Table 1. Since 2022, 30 Diabetes Community Specialist Teams (CSTs) have been established and work alongside Respiratory and Cardiology Community Specialist Teams to deliver the Model of Integrated Care for the Prevention and Management of Chronic Disease.

Implementation of the Modernised Care Pathways (MCPs) are key element of achieving the model and are being implemented since July 2023 across a number of these teams.

A key element of this model is the role of the Integrated Care Consultants who work 50% in the acute setting and 50% in the community setting. Through implementing these pathways referrals can be redirected from OPD to the Diabetes CSTs and new referrals from GPs can go directly to the CSTs, avoiding OPD.
