**Re PQ 35676 25** To ask the Minister for Health the estimated revenue from all parking charges at public hospitals in 2023 and 2024; and if she will make a statement on the matter

Dear Deputy Boyd Barrett,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. Your PQ above has been referred to me for response.

Hospitals introduced car parking charges over the past decade or so to cover such services' costs without impacting the hospitals' budget for patient services. As demand for car parking at hospitals increases, so too does the associated cost of providing these services, such as the initial capital cost of purchasing or renting parking areas, the cost of developing extra parking spaces, the need to provide and upgrade security systems, provide staffing and general maintenance of the car parks.

The HSE does not have a single contract to provide parking services at all hospitals, instead each hospital has its own arrangements, which reflect their particular circumstances. Some hospitals may use a third party provider to manage their car parks although the car parks may still owned by the hospital and some hospitals may have a third party to service parking meters, entry and exit barriers and security
