## PQ 36143/25

To ask the Minister for Health the number of children under 13 awaiting dental screening; the length of time they are waiting, by CHO, in tabular form; and if she will make a statement on the matter.

## Dear Deputy Sheehan,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for response.

The Health Services Executive delivers dental services to children under the age of 16, provided through 17 Dental Areas, all of which continue to provide routine services. The school dental service provides examination and any necessary preventive and restorative treatment noted at examination. The programme commences with 6th class and follows with 2nd and 4th - depending on available resources. As part of targeting of resources, each dental service maintains a commitment to urgent/emergency treatment for the relief of pain, infection, and the sequelae of trauma. The Department of Education publishes a National School Annual Census each academic year. Table 1 below provides indicative numbers per CHO of children entering these classes on 1st September of the academic year, which become the target classes for that academic year. The numbers are provided by CHO to enable cross reference between the KPI data and the school census data. This is provided by way of context.

The reported metric for the Dental Service is the number of new oral health patients in target groups attending for scheduled assessment. This includes children in target classes (2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup>) and any special care patients both adult and children who may have been targeted within the timeframe.
